9	Drones, camera-equipped multi-copters, remote-controlled helicopters, and any other devices capable of remote or autonomous flight
10	Animals (excluding assistance dogs for the physically disabled)
11	Items that could potentially be used as weapons (such as camera monopods or tripods, excluding white canes and canes required for medical reasons)
12	Laser pointers and any other devices that may obstruct event operations or the orderly conduct of competitions
13	Dry ice
14	Items that suggest political or religious views, discriminatory messages, or content against social norms, or that may disrupt the event, such as bulletin boards, signboards, flags, banners, streamers, placards,

15	Glass bottles and metal cans
16	Any other items deemed by the event organizer to obstruct event operations or competition progress, cause inconvenience or danger to others, or pose a risk of such outcomes

1	Engaging in acts that violate applicable laws or public order and morals
2	Bringing in or using prohibited items
3	Refusing to cooperate with security screening procedures, such as baggage inspection or body checks
4	Throwing or launching objects into the competition area or spectator seating, or engaging in any other behavior that may interfere with event operations
5	Operating or using drones or other unmanned aerial vehicles within or around the venue (except for authorized use by event organizers for competition coverage)
6	Entering restricted or off-limits areas, including competition zones, without legitimate authorization
7	Damaging, defacing, contaminating, or tampering with any buildings, equipment, facilities, or property
8	Destroying, opening, or altering locks, seals, tape, or other safety measures
9	Engaging in aggressive behavior such as threatening, intimidating, insulting, or provoking spectators, referees, athletes, or event staff (including posting such content on social media platforms)
10	Recording, transmitting, or producing photographs or videos of athletes that may be construed as sexually harassing in nature, or engaging in online defamation
11	Posting competition footage recorded inside the venue on social media or similar platforms.
	Note: "Posting competition footage" refers to uploading videos of the same competition (including sessions and award ceremonies) exceeding 10 minutes in length on television or internet platforms
12	Forcing or insisting on meeting with referees, athletes, or event personnel, or remaining in their vicinity without authorization
13	Blocking pathways, stairways, or entrances by placing baggage, spectating, or filming, or spectating in non-designated areas
14	Standing on seats or climbing fences or other structures within the venue
15	Smoking outside designated smoking areas within the venue (including electronic cigarettes and similar devices)
16	Using open flames within or around the venue without the express permission of the event organizer
17	Entering the venue in a state of intoxication or becoming intoxicated during the event
18	Using wireless communication devices within or around the venue (excluding mobile phones, smartphones, tablets, mobile routers, and small radios), unless authorized by the event organizer
19	Recording, transmitting, or producing photographs or videos for commercial purposes without the permission of the event organizer
20	Displaying, wearing, distributing, or posting political, ideological, or religious statements, content that violates public order or morals, discriminatory advertisements or signs, items used for demonstrations, as
	well as notices, flags, banners, placards, documents, printed materials, trademarks, or other items that may interfere with event operations
21	Conducting protest activities, demonstrations, gatherings, solicitations, speeches, or engaging in discriminatory speech or other actions that may hinder the smooth operation of the event
22	Engaging in commercial activities, fundraising, advertising, or other for-profit actions within or around the venue without the permission of the event organizer
23	Disposing of trash or other items outside designated areas
24	Entering, parking, or leaving bicycles or vehicles in unauthorized areas
25	Engaging in behavior that disturbs local residents or nearby facilities, such as illegal parking or sleeping outdoors near the venue
